Clarification of August 2, 2023 Market Rumors

### Background/Description of the Disclosure

AUGUST 03, 2023 – Rumors circulated yesterday that a supposed significant minority shareholder (more than 5% ownership of outstanding shares) of Converge ICT Solutions (PH:CNVRG) was positioned to sell-off its shares of the company. This rumor was further supported by an intelligence platform inaccurately presenting a significant position of this minority shareholder.

We would like to clarify that since the full sell-off of Coherent Cloud Investments, B.V. last October 2022, Converge did not have any significant non-public minority shareholder with more than 5% ownership of outstanding shares. All disclosures from Converge and Converge's stock transfer agent validate this statement. The intelligence platform has since corrected this in the afternoon of August 02, 2023.
